2016 Zone C Meeting Recap

The 2016 Zone C Meeting of the National Association of Credit Specialists was held in Lexington, KY from March 10-12.

The meeting began with a welcome from the Kentucky NACS President, Juanita Ballman. John McCauley, SED also welcomed everyone later in the morning. Throughout the day we also had presentations from Blue Cross & Blue Shield, FSA Benefits Planning, JM Marketing & American Farm Mortgage.

I would like to thank Juanita Ballman and the KY Planning Committee for all their hard work in the planning a very successful meeting. I would also like to thank Tiffany Grody for standing in for me Thursday night at the State Presidents Meeting and Juanita for getting the meeting started Friday due to my late arrival.

Lisa Liska- NACS FSA President

Lisa updated everyone on what the board has been up to since July. She gave an update on the status of the fraudulent activity on the NACS bank account and was able to report that we opened a new account and all the funds that were taken have been returned. She also stated that all checks have to be approved by Ryan at this time before the bank will honor them, and that Ryan asks for states to let him know when they send him check and when they clear so he can make sure nothing further happens for the next few months. Lisa invited everyone to the NACS National Convention in WDC on July 10-14th. We will be staying at the Residence Inn at the Capital and meeting next door at Patriot Plaza. If you plan on attending make sure to bring your LincPass to get into Patriot Plaza. In addition to our normal meetings we are planning a "Day on the Hill" for Thursday where we will be able to see our legislative committee in action as well as participate.

Val Dolcini, Administrator

Mr. Dolcini began by filling us in on some of his recent travels across the nation. He has had the opportunity to visit 37 states since becoming Administrator and has plans to visit the remaining states by the end of the year. He spoke about the large footprint that our agency has across the nation with our 2124 service centers, which is larger than any federal agency. Due to this we are the only connection many people have to the federal government.

Mr. Dolcini spoke on the importance of our loan program and how access to capital is one of the biggest hurdles that farmers face in the nation. Our microloan program has had its 3rd anniversary and we have made over 17,000 loans.

Finally Mr. Dolcini spoke on some of the things he wants to achieve by the end of this year. He intends on implementing a more robust succession planning so that when someone walks out the door we don't lose all their knowledge and contacts. Part of this will be assisted with Bridges to Opportunity (BTO). The BTO is creating a network of contacts for us so that we all have access to the resources and contacts that sometimes takes a career to develop.



Jim Radintz, DAFLP



We had another record year in 2015. Most direct FO loans- Ever; Most Beginning Farm (BF) Loans- Ever; 6000 Microloans (ML). BF being our biggest investment. In 2005, 21% of our loans went to BF, in 2015 54% went to BF.

FSA Guarantee portfolio is currently at \$13.3 billion with a delinquency of 2.15% for OL and 0.56% for FO for a combined total of 0.95%. FSA Direct Portfolio is currently at \$9.2 billion with a delinquency of 9.6% for OL and 1.9% for FO for a combined total of 6.3%. Of the delinquency ML and loans to BF have a lower delinquency then our whole portfolio.

The Objective for 2016 is to "Assure timely, equitable access to capital thru innovation, employee engagement & sound management." So far in 2016 compared to 2015: we are 16% ahead on DOL, 40% ahead on ML, 25% ahead on GOL and 25% ahead on GFO. Based on this it is anticipated that we may run out of funding in July/August. In order to manage our GOL funds, lenders should reschedule their existing guarantees and only request new money instead of refinancing. When they do this it cancels the existing guarantee and we have to set aside new loan funds.

Considering the slump in prices across the board for most sectors of agriculture we were reminded that we have many tools in our toolbox to assist our existing and new borrowers. Unfortunately some plans won't work. When a plan doesn't work we need to base our decision on the borrowers plan, but we may need to have an FSA plan as well. Keep in mind that we shouldn't allow our borrowers to "farm" their equity away. We should help to provide them with a graceful exit with dignity and respect.

National Office Goals: Succession planning- 60% of Headquarters staff can retire within the next 4 yrs; Creating a PT training; Continuing education that is effective and needed; CFAT; FBP Training. New Tools:

- Microloan FO- So far 20 have been made with Tennessee making the first one
- Online Application System Intend to be like an interview
- Cooperative Agreements will provide technical support, outreach and assist with application.
- How to be a borrower guide- to explain what borrowers responsibilities are
