The 2017-18 NACS Board had the honor of meeting with FSA Acting Administrator Steve Peterson, Under Secretary Bill Northey and many other Farm Service Agency and FPAC staff while attending the All-Association meeting held April 2-5 in Washington, D.C.

During joint and NACS-only meetings with leadership of FPAC, FSA and Farm Loan Programs, members of the board had the opportunity to voice concerns felt by many FLP employees. The intimate setting of these meetings allowed an open forum for many topics that, although discussed daily in the field, may not have been communicated to the National Office in other formats.

The opportunity for the NACS Board to travel to Washington D.C. to meet with Agency leaders serves as a compliment to the more formal NACS Resolution Process. The meeting also allows those in the National Office to connect faces with the names they see in NACS communications throughout the year. This personalized relationship opens the door to many NACS members to serve on various task forces and working groups developed to improve the day-to-day operations of Farm Service Agency's Farm Loan Program.
